ST JOHN-IN-BEDWARDINE ANNUAL PAROCHIAL CHURCH MEETING 11.30AM SUNDAY 23RD MAY 2021

The Vicar, Phil Bradford, took the chair. He noted that due to Covid-19 restrictions the meeting would be as short as possible. Questions had been invited before the meeting, but none were forthcoming.

Part 1 *The appointment of Churchwardens.*

The minutes of the meeting on 18th October 2020 (part 1) were approved.

There were two nominations for the post of Churchwarden, Gordon Templeton, and Joy Job. The meeting elected them both unanimously.

The Vicar thanked Gordon and Joy for all their work during the last year which has been made more difficult with guidelines constantly changing.

Part 2 The Annual Parochial Church Meeting.

The minutes of the meeting on 18th October 2020 (part 2) were approved as a true and accurate record.

For the PCC election: There were 5 vacancies. 4 people were proposed and elected: Amy Rees, Luise Horrocks, John Pound, and Jenny English. There is one vacancy.

For the Deanery Synod election: There were 2 vacancies and no nominations.

Appointment of Independent Examiner – All were in favour of the re-appointment of Grahame Lucas as our independent Examiner for 2021.

Following the yearly revision of the electoral roll, it now has 117 members.

The Vicar noted that all reports had been issued in advance in booklet form. He drew attention to the statutory reports. He thanked everyone for their great response to the difficulties of the past year.

The 2020 accounts and treasurers' report were contained in the annexe to the annual report's booklet. Phil Bradford proposed that the accounts were formally adopted. All were in favour, with one abstention.

Phil Bradford recorded thanks to Chris Rees for all the time and effort he had put into the accounts.

The Churchwardens' Annual Report for 2020 was accepted. The report on the proceedings of Deanery Synod was noted.

At the PCC Meeting held immediately following the APCM the following appointments were made:

Assistant Churchwarden: It was agreed to abolish the position of Assistant Churchwarden.

Lay Vice Chair: Colin Nash was re-elected unopposed.

Secretary: Liz Edwards (appointed as a non-member of the PCC, remunerated within her role as Parish Administrator) was re-elected unopposed.

Co-opted Members: No members were co-opted onto the PCC. (The PCC can have 2 people co-opted and this can be done at any time during the year).

Treasurer: Chris Rees was re-elected unopposed.

Composition of the **Standing Committee** was agreed as: The Vicar, Lay Vice Chair, Churchwardens, Treasurer, Graham Evans (as previous PCC Secretary), with Sarah Cottrill (Vicar of St Clements) invited to attend.

Flat 1A Bromyard Road: Phil Bradford had previously sent information around the PCC regarding works needed to bring the flat up to date in order to start renting it out again.

Phil proposed the following 4 points.

- 1. That the PCC authorises Andrew Grant's contractor to undertake these works as quoted.
- 2. That Brian Askew be authorised to arrange quoted for replacing the boiler and seek permission/quotes for installing secondary glazing, and to ensure that no other permissions are required for the internal works.
- 3. That the PCC approve the expenditure of up to £20,000 to cover all these works.
- 4. That an application be made by the PCC to the Feoffees to cover 80% of the cost (up to £16,000).

The PCC were all in favour.

Vicar's Annual Report

2021 was another challenging year, as we continued to live with the restrictions and uncertainties of Covid-19. The main difference from 2020 was that we did not face any compulsory suspension of services, while the vaccination programme allowed us to gradually open up throughout the year and (despite the blip of Omicron) look forward to 2022 with more optimism. If the pandemic still dominated much of 2021, at least we found ourselves being able to begin to look at other issues and confront some of the other challenges we face.

Although the country went into lockdown at the start of 2021, we were given the option of whether or not we closed the churches. Sarah and I were adamant that we should continue to offer worship in person, and I am very grateful to the standing committee and the PCC for their resolute support in that. We did offer a few months of online services in addition, which provided access to worship for some who would otherwise have been unable or unwilling to participate in person, and I am enormously grateful to Philip Evans for all the hard work he put into making this happen. Ultimately, however, I believe it was extremely important that we remained open for worship, as it provided a vital service to those unable to access the internet or for whom it was sometimes the only personal contact they had all week. Thanks are due to the ALMs who were willing to continue leading services across the churches, as well as to those who worked behind the scenes to ensure that we were able to continue to stay open while complying with the law.

There were, of course, sadnesses within this; worship with masks and distancing, and especially without singing and wine at communion, did not feel the same. Nevertheless, the key thing was that we did continue to have communal worship, and as restrictions eased through the year, we began to return to something more normal as singing, then the choir, then the chalice returned. If all was not quite as before by the end of 2021, given concerns over Omicron, we entered 2022 in a much better position than we had begun 2021.

Nevertheless, the aftermath has left us with serious challenges to confront. If numbers recovered somewhat from the lowest point during Covid, only the Tuesday morning congregation has returned to pre-pandemic levels. Sunday morning attendance remained down, and while this can in part be attributed to Covid (some were frightened of returning, others did not enjoy worship subject to restrictions), it is not the only cause. The Church of England neglected many of its members during the pandemic with its relentless focus on online provision, and doubtless we as a local church failed some people. There is also the reality that when a church loses its own vicar and the clergy are spread more thinly, pastoral care and congregation numbers suffer. With several deaths during the last couple of years, there has been a notable reduction in the size of the electoral roll. Financially, therefore, we are in a difficult position, with reduced income. While we have let the refurbished flat once again, the renovation did come at a cost, albeit one largely absorbed by the Feoffees. The new ministry share demands are high, which places further pressure on the budget, and we are facing the possibility of some major repair work on the Tower. While we need urgently to look at the matter of the pews, which in their current form are inhibiting key parts of our ministry and outreach, we lack both the resources to do anything and a person to drive such a project forward. There are thus considerable challenges to face in the immediate future.

Amidst that, however, let us not lose sight of the positives. A focus on Sunday congregation numbers can blind us to the important outreach and community work being done elsewhere. The resumption of Little Lambs has proved popular, and it has returned to full strength, to the extent that we are struggling with helpers and lack of space. Community breakfasts are now supplemented by popular coffee and cake afternoons once a month, along with Café Church and Women's Breakfasts. Discover History has started again and is once more attracting many people. There is a wider focus and interest, and all those who work so hard to put on these events and reach out to the local community are to be commended and thanked.

The Worcester City West Team finally came into existence on 1 July 2021, after numerous delays and years of frustration. St John's remains a separate parish within the Team, but we must actively look at closer collaboration with the others. This has already happened with St Michael's, as we now share a magazine, and they pay towards office costs. However, we are also looking towards more formal links (including a Joint Council) which will reduce unnecessary duplication of roles and workload, allowing us to concentrate together on our vision and mission in West Worcester in the years ahead. While there are issues which face St John's alone, not least the question of the building and its maintenance/reordering, the question of how best we serve the local community and minister in it is one we need to address on a Team level. This is especially important given the considerable amount of new housing which will be built in the local area in the near future.

There are many people to be thanked for their work in such a challenging year, and I cannot name them all here. However, I must extend my thanks to Gordon and Joy for all they have done as churchwardens, for the job is hard enough without the added pressure of a pandemic, and I am immensely grateful to them for all their support. St John's relies upon the hard work and commitment of so many people, and for that I would like to extend my thanks even if I cannot list everyone. We leave 2021 with considerable challenges, but with hope that we may gradually be able to put the misery of the pandemic behind us, and aware that we have many faithful people willing to work hard on our vision for the future.

Report on the proceedings of the Parochial Church Council

The PCC met 6 times during the year (May 2021 to May 2022), a short meeting to appoint officers following the APCM in May and 5 ordinary meetings in June, September, and November 2021, January, and March 2022. The meeting in June 2021 was held online, the rest were held in person as Covid restrictions had eased.

In May 2021 the PCC approved expenditure of up to £20K for the work on Flat 1a, Bromyard Road to bring it up to standard to be rented out again.

The Worcester City West Team came into place on 1st July 2021. The Team consists of St John-in-Bedwardine, St Michael's, and St Clement's with St David's.

In September 2021 the PCC voted in favour of the Team asking the bishop for an order under Paragraph 12 of Schedule 3 of the Mission and Pastoral Measure 2011, to allow banns to be called in any church in the Team (where applicable). This was granted in January 2022.

In September 2021 Revd Phil Bradford proposed that a Joint PCC be created for the Team, to delegate certain functions and avoid duplication of roles. The PCC were happy to look at this possibility. A proposed scheme, put together by Revd Phil Bradford and Philip Evans was introduced to the PCC in March 2022, whereby each parish will remain separate and the Joint PCC will be made up of proportionate representation from each parish.

During 2021 a Mission Group was formed consisting of a group of 9 people from all 4 parishes.

Following the APCM in May 2021 the PCC had 15 members, leaving one vacancy. The PCC currently has one Deanery Synod Representative, leaving 2 vacancies. Deanery Synod Representatives are elected for a 3-year term. The next 3-year term starts in 2023, but representatives can be elected for the final year of the current term.

During 2021 there was 1 wedding and 6 baptisms. These all took place in the last 4 months of the year when Covid restrictions has eased. There were 12 funerals held in church and 5 funerals were held at Worcester Crematorium for St John's Parish. There was also 1 burial of ashes held at St John's Cemetery.

The PCC operates through a number of formal sub-committees and other groups/teams. Membership of the committees etc (except the Standing Committee) is not restricted to members of the PCC.

When planning our activities, the PCC is aware of, and takes into account the Charity Commission's guidance on public benefit and, in particular, the specific guidance to charities concerned with the advancement of religion. The specific activities are reported throughout this document.

The PCC has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016 (duty to have regard to House of Bishops' guidance on safeguarding children and vulnerable adults.) Safeguarding information is clearly visible on the front page of the website. The safeguarding policy was reviewed and reapproved in March 2022.

Each meeting opened with a prayer and closed with all saying 'The Grace'.

A summary of the minutes of each PCC meeting is placed upon the main church notice board and is published in the magazine.

Safeguarding Report

Safeguarding continues with various updates being made all the time. DBS checks now need to be done every three years instead of five years. These are now done online, and the procedure is much quicker, with results usually coming back within 10 days. Thank you to all those who have recently had renewals carried out. All ALM's and people with a lead role in a group are having to take in-depth safeguarding training. They have had to submit written pieces of work and I know some people have found it daunting. However, after completing it I think most people have learnt from the experience. Thank you to all those who have completed the course.

We have continued to work through the parish dashboard. The regulations for appointing people into roles paid or voluntary now have to be carried out. This can sometimes be very time consuming but needed to ensure that any appointments can be as safe as we can possibly make them. It is often difficult to get the balance right with all the checks, job descriptions, references etc. that we have to get for a new role. However, we can see how important it is and we hope those of you involved in these procedures bear with us.

As always, at St Johns we take safeguarding seriously and rely on the congregation continuing to be vigilant and report anything they are concerned about regarding the safety of vulnerable children and adults. Even with all the necessary checks taken there could be individuals who can beat the checking system. It is therefore important that all those in the congregation remain vigilant and report anything they have a concern about with reference to safeguarding. Safeguarding concerns everyone.

Events Team Report

Following the dreadful years of the pandemic the team have started to bring back people into the church with the Good Old Days talks. These talks by Paul and Helen Harding from Discover History have always been very popular and we hoped that starting them again would help get people out and about again post-pandemic. The first talk was planned for October 2021 and was about the Home Guard in Worcester during WW2. We were extremely happy to see about 40 people turn up to enjoy the talk and have the now-traditional tea and cakes during the half time. Since then, the numbers have slowly increased, and we are getting about 60 attendees now at the talks. The team took the decision to charge £4 for the talk and refreshments and that has ensured that they have been able to cover the costs and make donations into church funds.

We have more people signed up for these trips and are therefore hopeful that they will become regular events again taking those people that find travel more difficult these days to places that they would not otherwise be able to visit.

Communications

Our website, https://www.stjohninbedwardine.co.uk/, continues to grow with new users visiting on a regular basis. In the last year we had some 5,600 users, which is up from the 3,000 we had the last time I reported. The more information we can put out on the website then the more users we will get coming to read what we have to say and are doing. The access to our website is inextricably linked to our use of our Facebook page as well, as by putting information on Facebook but linking it to a main story on the website draws people in.

Facebook is really becoming key to getting our message out to the local community, https://www.facebook.com/stjohninbedwardine. Our posts regularly reach 300 people, but we have had some notable posts, such as Sandra Nash's photo of the Cathedral rising above the fog that reached nearly 3,000 people and the recent Easter Craft Activities and the Lions Ukrainian Appeal that both reached 2,200 people. Since we had some interaction with people on the WR2 Residents Facebook page, https://www.facebook.com/groups/995802520837333, I have been using this as a secondary outlet for our information and stories. Many more people access this page, and it has proved quite useful in getting our information shared with the local community.

We still use our A Church Near You website, https://www.achurchnearyou.com/church/18634/, as a means of sharing information with those people who do not know what churches are nearby, it tells them what is going on in their local churches.

I am always keen to get items that need to be advertised on our various communications channels, but as I cannot know what is going on all the time, I do need people to let me know what they are doing and want to be advertised. We do know that the use of Facebook does increase the spread of our information.

Churchyard

Things have gone very well during the last year in the churchyard. Following some comments on the WR2 Residents Facebook page a couple of keen local gardeners approached me and volunteered to help, which together with a Ukrainian gentleman who started helping me once we opened after the pandemic means that there are regularly a team of 4 working in the churchyard on a Tuesday morning. This has allowed us to get on with some of the tasks that I just could not tackle on my own.

Some of the tasks that we have managed to do include:

- We have cleared all the weeds from in front of the gravestones, laid weed suppressant membrane and covered it with bark chippings, this has made a great difference as the area looks much tidier and we do not have to spend time, each month weeding it.
- We have done similar around the fallen tree, the ivy-covered elephant sculpture, but just need to get some more bark to finish covering. Some trees, shrubs and other plants have been planted through the membrane to improve that area.
- We have really had a clear up of the future wildflower 'meadow', getting rid of as much of the grass as we can to allow the wildflower seeds to grow and gain a hold before the grass overtakes the area. This area we will need to keep on top of.
- At the east end of the church, where the old Yew tree fell done a couple of years ago, we have planted some shrubs to create a small shrubbery there.
- We had a good clear out of the conservation area during the spring and have plans to plant up some more wildlife-friendly shrubs and trees there.

Our future plans include planting some trees as part of the Queen's Green Canopy initiative, extending the wildflowers all the way to the road, and increasing the size of the Rose Garden in the corner by the gravestones. I would really like to get some proper noticeboards to tell people about the churchyard, but they are expensive, so I need a plan to raise the funds for them!

I would like to thank everyone who has donated time or money towards the work in the churchyard, especially my helpers, Jacqui Adams, Angie Wall, and Alex Koval. I do not think a week goes past when we are working out there that someone does not stop to say how much they enjoy coming into the churchyard and how good it looks. It is a real boost to us all for the work we put in.

I have now finished researching the burials in the churchyard up to the date the 'New' churchyard closed in October 1878. I have now identified around 9,600 burials that took place in the church and are therefore interred in the churchyard. This is an incredible number and one of the reasons that the soil is so high compared to the local roads and pavements.

ESTATES MANAGER'S REPORT FOR 2021

- 2021 was an improvement over 2020 but there were still regulations which meant
 that the church usage was far less than it normally would have been. Again, the
 priority was to ensure that the building remained safe and that nothing was festering
 which could cause long term damage.
- The main item, which occupied a lot of people's time, during the year was the refurbishment of the flat above the Parish Office. Following the death of our previous tenant, Charles Burnett, an inspection of the flat was carried out by church officials and a representative from Andrew Grant our letting agent. Due to the poor condition of the flat it became clear that the only option was to do a full refurbishment kitchen, bathroom, boiler, decoration, flooring etc. There then followed a protracted period of trying to get quotes but, eventually, a Redditch based company did the work and some £20.000+ later we had a flat that we could re-let. A new tenant moved in just before Christmas and all seems to be going well.
- All our fire safety equipment and gas safety checks were carried out without any issues. We also had our lightning conductor tested – luckily without any issues as that can be very expensive. The only outstanding safety check is the portable appliance testing (PAT) of the non-IT items. Everyone is playing catch-up, so it is difficult to get contractors to come in for very small jobs.

- John Slater inspected the bells, and associated equipment, in March, and found no issues of concern. Due to inactivity the bells had only been inspected annually instead of the normal six months.
- The disabled toilet has an ongoing damp problem (on the north wall) due to a poor arrangement of lead and coping stones on the flat roof. We have carried out a couple of modifications to try and improve the situation. The facing lead has been redressed to steer rainwater away from the north wall rather than directing it down the wall and the wall itself has been treated with a water repellent spray. So far, the signs are good but it's a bit too early to claim a total success.
- The five-year inspection of the Church's fixed electrical system was eventually carried out, following a year's delay, and passed without any issues being raised.
- All the equipment in the kitchen is 15+ years old and the dishwasher is showing its age. My catering experts tell me it has been on its last legs for a few years. However, we keep patching it up, but a replacement will inevitably soon be required.
- As mentioned for a few years, the exterior stonework on the tower needs some serious restoration. We must make sure that this work isn't forgotten and engage with the buildings team at the Diocese to determine a way forward.

Report on the proceedings of the Deanery Synod 2021-22

This report is a synopsis of the work of the re-formed Deanery Synod for the Worcester Area for the year 2021.

Our first meeting was in March and was opened by the new Area Dean, Revd. Diane Cooksey. Our zoom meeting showed 63 active screens including members from the former deaneries of Martley and Worcester West, Worcester East, and the Saltway Team (part of the Droitwich Deanery). We were given instruction by the two Archdeacons and Bishop Martin as to their expectations and Diane Cooksey was commissioned.

Our June meeting was again held on Zoom with Alison Maddocks in her new role as 'Dean of Smaller Churches' speaking to us. We were told that the current definition of a 'smaller church' is based on an Electoral Roll of 20 or less. The 2018 figures are in use at this moment.

The September meeting was supposed to be 'face to face' and incorporate a Deanery Service to be held at All Saints in the Deansway. Unfortunately, there were misunderstandings about attendance, so turnout was low. As it was, those few that attended enjoyed the experience.

November's meeting was again back on Zoom. John Preston the Diocesan Secretary dealt with the financial health of the Diocese and explained in detail why certain decisions are being taken on our behalf.

A Deanery Questionnaire was prepared by the Leadership Team and most churches, though not all, have replied to that. Analysis of those answers is taking place at the time of writing this summary and some of that evidence and examples will be used at the Diocesan 'Open Conversations 3' due to be held throughout 2022.

Deanery Synod always used to be referred to something along the lines of a 'group of people in a meeting waiting to go home' and many felt that it had lost its way in the greater scheme of things. By reducing the number of Deaneries and increasing the sizes to now include both Rural and Urban Churches there is a strong chance that your church can, by using the stronger voice of an expanded group, have a meaningful input into the Worcester Diocese. I urge you to make sure that your Representatives regularly report back to you and that you also ensure that your views and wishes go back, via them, into the melting pot.
